Express your opposition to the MD State Highway Administration's proposed wasteful spending of \$1 million dollars of our hard earned tax dollars on the feasibility study for the Terrapin Expressway.

Here are some suggested points to emphasize while calling:

- **Pouring money into more roads to accommodate more cars will only make our problems worse.**
- **The addition of the interchange will encourage more students to drive to and around campus, which will mean increased traffic on an already over-congested I-95 / I-495 corridor. It would also mean additional traffic on Metzerott Rd, Adelphi Rd, University Blvd, Route 1, and surrounding neighborhood streets, as they are used as access routes onto these highways.**
- **With the budget deficit in MD, this money could be better used for pre-existing road improvement projects in the area, instead of being wasted on this feasibility study.**
